Thermo Fishersheville versus Fisher Scientific

Business Services has noted several instances where departments are attempting to order from Fisher Scientific yet using the supplier Thermo Fisher Scientific (Asheville). Thermo Fisher Scientific (Ashville Supplier ID 000154079, and they typically supply equipment and repair setting LU orders are issued to Thermo Fisher Asheville. Fisher Scientific is Supplier ID 000010457 and has a catalog in Billiken Buy with lab supplies. Most POs issue 8 die Fiister catalog orders that are initiated in Billiken Buy.

When a PO is mistakenly issued to the wrong supplier, it must be canceled, and a new PO created wit the correct supplier. In many cases, departments are not aware that a PO has been issued to the wron
